## **Domestic Insurance Consolidated Statistics**

This is the **50<sup>th</sup>** issue of the Turks and Caicos Islands Financial Services Commission's Domestic Insurance Statistics Publication. It provides information on activity in the Domestic Insurance sector as at 31<sup>st</sup> March 2024 and the comparative results as at 31<sup>st</sup> March 2023.

As at 31<sup>st</sup> March 2024, there were four long-term insurers; 12 general insurers; two composite insurers; 11 insurance brokers; nine insurance agents; and 10 insurance sub-agents as listed below:
