## FINANCIAL SANCTIONS NOTICE

## Russia

- The International Division of the Attorney General's Chambers advises that five (5) entries have been added to the <u>Russia Sanctions Regime</u><sup>1</sup> and are now subject to an asset freeze and trust service sanctions.
- 2. One (1) entry has been amended and is still subject to an asset freeze and trust service sanctions.
- 3. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.
