FINANCIAL SANCTIONS NOTICE

FSN-16-25 24/02/2025

Russia

- The International Division of the Attorney General's Chambers advises that sixtysix (66) entries have been added to the <u>Russia Sanctions Regime</u>¹ and are now subject to an asset freeze and trust services sanctions.
- 2. One (1) entry has been added and is now subject to an asset freeze, trust services sanctions and a prohibition on correspondent banking and clearing.
- 3. One (1) entry has been amended and remains subject to an asset freeze and trust services sanctions.
- 4. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.
