## FINANCIAL SANCTIONS NOTICE

## Russia

- 1. The International Division of the Attorney General's Chambers advises that four (4) entries have been corrected in the <u>Russia Sanctions Regime</u><sup>1</sup> and are still subject to an asset freeze and trust services sanctions.
- 2. One (1) entry has been corrected and is still subject to an asset freeze, trust services sanctions and a prohibition on correspondent banking and clearing.
- 3. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.
