Russia

1. The International Division of the Attorney General's Chambers advises that one (1) entry has been removed from the [Russia Sanctions Regime](#)¹ and is no longer subject to an asset freeze or trust services sanctions, as follows:
 - Farkhad AKHMEDOV (Group ID: 15263)
2. Two (2) entries have been corrected and are still subject to an asset freeze and trust services sanctions, as follows:
 - MCR GLOBAL ELEKTRONIK SANAYI VE TICARET LTD SIRKETI (Group ID: 16766)
 - POLY TECHNOLOGIES, INC (Group ID: 16828)
3. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.

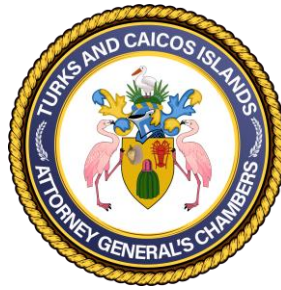

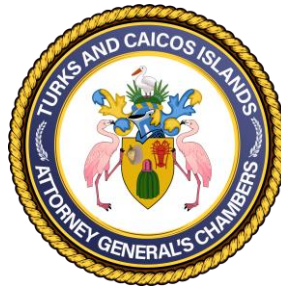
