## Russia

- 1. The International Division of the Attorney General's Chambers advises that two (2) entries have been amended in the <u>Russia Sanctions Regime</u><sup>1</sup> and are still subject to an asset freeze and trust services sanctions, as follows:
  - 2RIVERS DMCC (Group ID: 16717)2RIVERS PTE LTD (Group ID: 16716)
- 2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.
