Russia

- 1. The International Division of the Attorney General's Chambers advises that three (3) entries have been amended in the <u>Russia regime</u>¹ and are still subject to an asset freeze and trust services sanctions, as follows:
 - Demetris IOANNIDES (Group ID: 15871)
 - Galina Evgenyevna PUMPYANSKAYA (Group ID: 14728)
 - Dmitry Alexandrovich PUMPYANSKY (Group ID: 14726)
- 2. This follows an update to the UK Sanctions List. The consolidated list of asset freeze targets has been updated to reflect these changes.

The principal Order was amended pursuant to the Russia (Sanctions) (Overseas Territories) (Amendment) Order 2022, the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 2) Order 2022, the Russia (Sanctions) (Overseas Territories) (Amendment) (No. 4) Order 2022 and the Russia (Sanctions) (Overseas Territories) (Amendment) Order 2023, which are in effect for the Islands.
