Non-Domestic Insurance Consolidated Statistics

This is the 3rd issue of the Turks and Caicos Islands Financial Services Commission's Non-Domestic Insurance Publication. It provides aggregate information on activity in the Non-Domestic Insurance sector, excluding Producer Affiliated Reinsurance Companies¹, as at 31st December 2022, and the prior four years comparative results.

All non-domestic insurers are required to appoint an insurance manager in the Turks and Caicos Islands. The following eight insurance managers were licenced to carry on business in the Turks and Caicos Islands as at the 31st December 2022:

- 1. Aberdeen Insurance Managers (Turks and Caicos) Ltd.
- 2. Caribbean Insurance Management Services Limited
- 3. Claymore Insurance Management (TCI) Ltd.
- 4. Connected Captive Solutions (Turks and Caicos), Ltd²
- 5. Global Insurance Managers and Actuaries Ltd.
- 6. International Insurance Managers Limited
- 7. Marlin Limited
- 8. Tradewinds Insurance Management Group Ltd.

At as 31st December 2022, there were 70 non-domestic insurance companies licensed in the Turks and Caicos Islands: 60 general insurers and 10 long-term insurers, see Table 1 below. These insurers were distributed as follows:

- o 3 protected cell companies ("PCC"),
- o 9 unaffiliated direct insurers,
- o 12 reinsurance companies,
- o 17 endorsed to act as direct writers for producer affiliated reinsurance companies, and
- o 29 pure or group captives.

During the year under review, five (2021: six) new non-domestic insurance licences were issued and seven (2021: four) licences were cancelled.
