PROCESSING TIME PRODUCER AFFILIATED REINSURANCE COMPANY

This is the 5th issue of the Turks and Caicos Islands Financial Services Commission's publication on Processing Time for Producer Affiliated Reinsurance Companies' ("PARCs")¹ applications. Processing time is measured from the date that a complete application is received by the Commission to the date of dispatch. This publication provides information on the types of applications received and the relevant processing time.

For the period **January to March 2022** a total of 264 applications were received by the Commission. Of this amount, 34 applications were deemed incomplete and returned to the respective agents. Additionally, requirement emails citing deficiencies were sent for 181 applications received during the period. Table 1.1 provides an analysis of the processing time achieved.

For the period **April to June 2022** a total of 239 applications were received by the Commission. Of this amount, 11 applications were deemed incomplete and returned to the respective agents. Additionally, requirement emails citing deficiencies were sent for 131 applications received during the period. At the date of this report there are currently 21 applications awaiting documents for further processing. Table 1.2 provides a breakdown of the processing time achieved.
