## PROCESSING TIME PRODUCER AFFILIATED REINSURANCE COMPANY

This is the 6<sup>th</sup> issue of the Turks and Caicos Islands Financial Services Commission's publication on Processing Time for Producer Affiliated Reinsurance Companies' ("PARCs")<sup>1</sup> applications. Processing time is measured from the date that a complete application is received by the Commission to the date of dispatch. This publication provides information on the types of applications received and the relevant processing time.

For the period **April to June 2022** a total of 242 applications were received by the Commission. Of this amount, 17 applications were deemed incomplete and returned to the respective agents. Additionally, requirement emails citing deficiencies were sent for 131 applications received during the period. Table 1.1 provides an analysis of the processing time achieved.

For the period **July to September 2022** a total of 225 applications were received by the Commission. Of this amount, 22 applications were deemed incomplete and returned to the respective agents. Additionally, requirement emails citing deficiencies were sent for 144 applications received during the period. Table 1.2 provides a breakdown of the processing time achieved.
