PROCESSING TIME PRODUCER OWNED REINSURANCE COMPANY

This is the 2nd issue of the Turks and Caicos Islands Financial Services Commission's publication on Processing Time for Producer Owned Reinsurance Companies' ("PORCs") applications. Processing time is measured from the date that a complete application is received by the Commission to the date of dispatch. This publication provides information on the types of applications received and the relevant processing time.

For the period **April to June 2021** a total of 326 applications were received by the Commission. Of this amount, 29 applications were deemed incomplete and returned to the respective agents and 31 applications were awaiting requirements and/or were unprocessed as at the end of the reporting period. Table 1.1 provides a breakdown of the types of applications received and an analysis of the processing time achieved.

For the period **January to March 2021** a total of 308 applications were received by the Commission. Of this amount, 24 applications were deemed incomplete and returned to the respective agents and 1 application was awaiting requirements and/or was unprocessed as at the end of the reporting period.
