PROCESSING TIME PRODUCER OWNED REINSURANCE COMPANY

This is the 4th issue of the Turks and Caicos Islands Financial Services Commission's publication on Processing Time for Producer Owned Reinsurance Companies' ("PORCs") applications. Processing time is measured from the date that a complete application is received by the Commission to the date of dispatch. This publication provides information on the types of applications received and the relevant processing time.

For the period **October to December 2021** a total of 237 applications were received by the Commission. Of this amount, 17 applications were deemed incomplete and returned to the respective agents and 10 applications were awaiting requirements and/or were unprocessed as at the end of the reporting period. Table 1.1 provides a breakdown of the types of applications received and an analysis of the processing time achieved.
